By participating in this interactive and informative training, you will have the possibility to become an expert in the field of **monitoring hate speech and counteraction, documenting the phenomenon, tackling underreporting, comparing results as well as producing effective counter-narratives**. The training will include interactive sessions on how to recognise hate speech, the importance of monitoring and the art of documentation. An expert trainer from the *International Network Against Cyber Hate (INACH)* will join the training for a 1-hour morning session in order to give an understanding of how to use the INACH databank for documenting cyber hate.
